MOUS WORTH ₹49,975 CR inked on first day of VGS 2015

This is over and above Rs1,20,000 crore announced by Reliance and Birla groups

Ahmedabad: The first day of seventh edition of Vibrant Gujarat Summit (VGS) started with 31 memorandum of understandings (MoU). As most of them are in social sector or mutual cooperation amount of investment in the state, however seemed small at Rs49,975 crore, with Gautam Adani contributing half of that with its Rs25,000 crore solar photovoltaic cell production facility.

"8 to 12 important MoUs were inked during different themes seminar, while the total MoUs were 31," additional chief secretary of education department, Arvind Agrawal, announced on Sunday evening.

Meanwhile, it should be noted that taking part in inaugural ceremony two of the country's biggest business houses announced invest Rs1,20,000 crore in Gujarat. The first announcement came from India's richest man Mukesh Ambani and chairman of Reliance Industries.

He proposed investment worth Rs1,00,000 crore in the field of his company's operational projects in energy, petroleum, retail and telecom. Chairman of Aditya Birla Group, Kumarmangalam Birla announced to invest Rs20,000 crore in his group's copper, VSF and chemicals facility in the state.

An official release says, other key MoUs were inked by Rail Vikas Nigam Limited for rail systems and Indo-Chin Development Private Ltd for a trade centre. On the theme 'Gujarat: preferred hub for defence production', seminar as many as 11 MoUs were signed but only one in defence sector.

Welspun Group's signed an MoU for an integrated steel plant, Pradip Overseas Ltd in specialty, fine chemical and auto components while Syntex industries made a pact in plastic products.

Twelve MoUs were signed in field of innovation in food processing for sustaining food security. The Ratan Tata and Navajbai Ratan Tata trust inked an MoU to develop 60,000 households for tribal community.

According to a statement, Nabard will initiate strategic partnership for training and capacity building of self help groups while CIPET Ahmedabad under its MoU will give vocational training to 9,000 tribal youths in Valsad district.
