Annex (addendum) 1: Agreement on Commission Fees

Minaean SP Construction Corporation agrees, by signing this document, to pay to the International Business Development Team following operations start up on projects in the Republic of Colombia and nearby Countries (directly to each: 1% to Juan Evangelista Sanchez Niño, Kresky Environmental SAS & his regional managers + 0,5% to Paola Viviana Murrillo, Mirrai International + 0,5% to Mauro De Simone, MDS Linea Design International Ltd.) on behalf of Minaean SP, a **2% Commission Fee**, calculated on the overall value of the construction costs assigned to Minaean SP. (No Commission Fees will be paid by Juan Evangelista Sanchez Nino, Kresky Environmental SAS, nor by Paola Viviana Murrillo (Mirrai International), nor by Mauro De Simone (MDS Linea Design International Ltd.)

Payments will not be done by Minaean SP up front, but all payable upon collection of payments by Minaean SP from the projects clients.

The International Business Development Team is composed by: Juan E. Sanchez N. (Kresky Environmental SAS), Paola Viviana Murrillo (Mirrai International) & Mauro De Simone (MDS Linea Design International Ltd.)

Mauro De Simone (MDS Linea Design Int'l Ltd.) is not and will not be involved with Minaean SP in projects regarding Energy Wind Plants, Gold Mines Exploration & Development, Oil & Pipelines Infrastructures.
